KEY TERMS ON WHAT YOU CAN, CAN'T AND MUST DO WHEN SELLING/TRANSFERRING MATCH TICKET(S)

This document is not a substitute for reading and making sure you understand and comply with the full RFU Ticket Terms and Conditions (the “Terms”)

MEMBERS CAN:

- 1.** purchase a ticket from an Eligible Entity you are a Member of (Club, Constituent Body, Referee Society, school, Overseas Union or RFU Partner) to attend the match yourself. Any other transfer/sale including using ticket(s) for good causes requires prior approval from the RFU
- 2.** purchase additional ticket(s) from the Eligible Entity you are a Member of for guest(s) to attend the match with you and transfer/sell those ticket(s) to your guest(s)
- 3.** post/list tickets on the official England Rugby Ticket Exchange

MEMBERS CAN'T:

- 1.** transfer/sell ticket(s) above face value (a £10 (inc VAT) admin fee is permitted)
- 2.** transfer/sell/advertise ticket(s) through secondary ticketing sites such as Viagogo or Stubhub (you are only permitted to do so via the England Rugby Ticket Exchange)
- 3.** sell/transfer tickets as part of a package e.g. with food, drink, hospitality, travel etc
- 4.** enter into any sponsorship arrangement with respect to the ticket(s)
- 5.** use ticket(s) as a prize or part of a competition, auction or similar activity
- 6.** use ticket(s) or allow them to be used as part of a promotion or to pass off an association with the RFU, England Rugby, a team or match
- 7.** transfer/sell ticket(s) to anyone other than as detailed on the previous page without RFU's prior permission.

MEMBERS MUST:

- 1.** make sure that you fully understand the Terms
- 2.** where you obtain ticket(s) from an Eligible Entity you are a Member of and you are unable to attend the match yourself then if your guests are not also Members of the same Eligible Entity that transferred/sold you the ticket(s), you must either: (a) return all ticket(s) that you obtained to the Eligible Entity that sold/transferred the tickets to you originally; or (B) list such ticket(s) on the England Rugby Ticket Exchange
- 3.** only transfer/sell/offer for sale/transfer ticket(s) in accordance with the Terms
- 4.** provide ticket(s) directly to the recipient and not via a third party (other than postal or delivery service or England Rugby Ticket Exchange)
- 5.** incorporate the Terms and Ground Rules into all agreements to sell/transfer ticket(s)
- 6.** make those you are allowed to transfer/sell ticket(s) to aware of the Terms and make sure that they comply with them
- 7.** keep records of who you have transferred/sold ticket(s) to for a minimum of 2 years and provide it to the RFU within 7 days on request
- 8.** the ticket(s) they received on the official England Rugby Ticket Exchange.
